The President addressed the meeting and spoke about the importance of the 4 Pillars of Health for our minds and bodies: Nutrition; Exercise; Relaxation and Sleep. Each members' involvement in the rowing club is an important contributor to our own health and builds connections with others.

The Treasurer addressed the meeting and explained to members that the current financial position had been built up over a six year period. Funds are currently held for hall refurbishment and additional funds may be released for boat purchases once the bathroom renovations are contracted. In the meantime, members could assist with fundraising for boats and equipment and by volunteering. Coaching and boat purchases are paid for from hall hire revenue. The treasurer confirmed that a budget for fundraising existed for FY22-23, and encouraged members to work with the Fundraising Coordinator to meet or exceed the budget.

The Captain reminded members of the importance of logging incidents so that repairs could be undertaken on a timely basis and to minimise the impact on other rowers.
