5. Confirmation of minutes of the 2022 Annual General Meeting

The minutes had been circulated to all members prior to the meeting and were:

6. Proposed Rules Changes discussion

The committee explained that the proposed rule changes were drafted for a number of reasons including:

- a need to bring them into line with current legislative requirements and community expectations
- a need to make the language more inclusive

Members raised a number of questions regarding the process for amending the rules. The main concerns raised were

- The need to vote on all changes under one vote, instead of allowing separate votes on individual changes
- The intended removal of proxy voting
- The lack of socialisation of the proposed changes with members. Noting that some members were not aware of the work being undertaken.

The committee sought to assure members that there was no intended secrecy behind the changes, and members acknowledged and thanked the sub-committee involved for the time they spent in drafting the changes.

7. Presentation and consideration of Annual Reports of activities during the year

The Treasurer addressed the meeting and explained to members that the current financial position had been built up over a six year period. Funds are currently held for hall refurbishment and additional funds may be released for boat purchases once the bathroom renovations are completed. In the meantime, members could assist with fundraising for boats and equipment and by volunteering. Coaching and boat purchases are paid for from hall hire revenue. The Treasurer confirmed that a budget for fundraising existed for FY23-24, and encouraged members to work with the Fundraising Coordinator to meet or exceed the budget.

The Captain reminded members of the importance of logging incidents so that repairs could be undertaken on a timely basis and to minimise the impact on other rowers.

7. Presentation and consideration and acceptance of Financial Statements for the year ended 31 May 2023

The Treasurer invited questions from the floor in acknowledgement of the delayed provision of reports:

Basis for Valuation of the premises

Treasurer advised that a valuer has been engaged to prepare an insurance valuation to include the recently completed bathroom renovation and FY23-24 financial statements would likely reflect an increase; our financial statements are special purpose statements with basis of valuations included in the Notes; and if the valuation of building was too low the only impact on the Financial Statements would be to increase the Members Equity (no cash impact);

Length of service of the Auditor

Treasurer advised all payments had 2 signatories and segregation of duties between Treasurer, Assistant Treasurer and Bookkeeper were designed to prevent fraudulent activity or reporting. Treasurer acknowledged the review of the Financial Statements for compliance with Accounting Standards, prior to submission to the auditor, by a club member who was an experienced Chartered Accountant. The newly formed Audit & Risk Management subcommittee has auditor performance, independence and fees within their Terms of Reference.

Due to the late circulation of the Audited Financial Statements a 20-minute adjournment was granted, giving members a chance to discuss any questions or issues that they had with the Treasurer.

Upon completion of the adjournment the Financial reports, including the documents noted 7a - 7d were approved via a show of hands.

Locker policy - Charlie Burke voiced his concerns about the new policy implemented from July 2023 regarding lockers in the RRC changing rooms.

Charlie offered to provide maintenance on the lockers if this would assist in keeping the lockers available at no charge.

The committee thanked Charlie for his offer and explained that maintenance was only one factor in the fee being introduced. The primary concern here is that not all members have equal access to a locker, and a policy was needed to reflect this.
