PRESIDENT'S REPORT

It has been a busy and successful year for Richmond, both on and off the water.

The competitive season kicked off with the Essendon Saltwater regatta, but as the first post Covid season, 2022-23 was still profoundly affected by regatta cancellations, mostly due to weather events. Despite this, entries from RRC were back to pre-Covid levels, a testament to the hard work and enthusiasm of coaches and committee in maintaining member engagement. A big thank you to Christine Sullivan who served as Head of Rowing and to Michael Hedger who has now taken on that role.

Melbourne Head and Carrum regattas were followed in the New Year by old favourite Rutherglen. Summaries of the various sprint regattas and masters regattas are available on the blog. Richmond crews were State Champions in the following events: WOClub2x, WClub 1x, WA2x, WA1x, WC4x+, WC4+, WC8+, WB2-, MC8+, MC4x+. Richmond finished second in the overall Club Grade Premiership, and fifth in the Masters standings. There was a small contingent (3 females, 1 male) competing at National Masters Championships where the club finished 26th of 96 clubs in the overall standings. Members Helen Pearce and Geraldine Goss represented Victoria in the interstate 4x and 8+ events, winning gold and silver respectively. Well done to all rowers, coaches, coxswains, and volunteers!

The club was a hub for the Australian Indoor National Championships, which saw a huge participation from RRC with many medals won. The goal will be to continue to be a host/hub for this exciting event.

We have welcomed many new members with a large group graduating from Learn to Row into Development Squad and another contingent of experienced rowers being welcomed back to the world of rowing. Participation at regattas was facilitated by those who towed the trailer, and those who took on BRO/volunteer duties. We are extremely grateful to all our volunteer workforce. Club functions were organised under the brilliantly organised hand of Helen Pearce.

A major renovation of bathrooms and changerooms was undertaken, which has raised the level of our facility and will act as a future proofing exercise to maintain our hall hire revenue. Membership fees do not cover the costs of running the club, and offerings such as new fleet, coaching and other upgrades depend on revenue from hiring the facility. The club owes a debt of gratitude to Richie Healy, who spearheaded this project, with thanks also to Barry Campbell for his assistance.

The Finance Subcommittee saw revisions of the Financial Policies documents as well as the Annual Budget and I am indebted to fellow Finance subcommittee members Kathy Macrow and Jack Hellerstedt.

Member well being is a top priority, and the club is bound by the Rowing Australia Member Protection policy. We have revised our procedures and policies around member safety and have welcomed the contribution of Derek Begg as Member Protection Information Officer. Several committee members underwent training in the National Integrity Framework policies, and we continue to evolve club policy. The club is a place where members can optimise opportunities for physical and mental well-being, especially with social connection, and we constantly seek ways to enhance these opportunities.

The 160th committee undertook many tasks during the year, many following from the Strategic Planning Day in 2022. These included Policy review, training in the new National Integrity Framework and integration of new ventures, including the Proud to Play and Clubs with Heart initiatives. This has largely been spearheaded by the Diversity and Inclusion Subcommittee of Richie Healy, Kirsty Fergie and Geraldine Goss. Huge contributions were made by the Audit and Risk Management SubCommittee, led by Sarah Hardy and Alex Reid. Working Groups revised criteria for Club Awards and Resource Allocation. A Working Group comprising Ally Dejaegher, Derek Begg, Richie Healy, Jack Hellerstedt and myself spent over 100 hours revising the Clubs very outdated Rules, making the language more inclusive and updating processes. Hopefully the changes will bring the club into line with its responsibilities, especially regarding member protection and as an employer. Huge gratitude to all who contributed time and effort into these Subcommittees and Working Groups.

The club reappointed Will Golding as Head Coach. Will continues to run the highly successful TopRow venture and has been a great face for the club. We look forward to seeing his vision unfold. Will was appointed Rowing Victoria's Coach of the Year for season 2021-2.

We celebrated the wonderful season at our Presentation Night and honoured our award winners. The President's award was won by Phil Munson for outstanding volunteering for the Club. Rowers of the year were Kate Dyball and Ben Wardle, with coxswains Ally Dejaegher and Derek Begg in a tie for the Coxswain of the year Award. James Merrett was best First Year Rower.

We are grateful to retiring committee members: Captain Kim Beglehole looked after our boats brilliantly and led the Fleet Subcommittee. After many years of service as Captain and then as Facilities coordinator, Barry Campbell steps down. Sarah Houghton served for 2 years as General member. Christine Sullivan retired from the Head of Rowing role, after serving in this and the Facilities role for several years.

Finally, the committee itself devoted much time to improving its own workings. I am very grateful to the hard-working committee of 2022/23 and cannot express my gratitude more. I would especially highlight the contribution of Jack Hellerstedt, who served as Secretary for 2 years. His contributions to club policy and his insights and humour will be greatly missed. I look forward to a successful 2022/23, with an amazing lineup having put their hand up to serve the club.

SECRETARY'S REPORT

From August '22 to June '23 inclusive, we welcomed 53 new members, and had approximately 130 active rowers registered with Rowing Victoria.

It was an honour and privilege to work with Ally, Derek, Gerry, and Richie on the rules revision working group and I'm quite proud of the draft we have tabled for a vote at the 2023 Annual General Meeting.

Vale life member Robert Juggins, who passed away in May 2022. Bob was made a Life Member for his instrumental contribution in helping the Club survive the disastrous fire of 1970. Bob was a member of Corio Bay Rowing Club and was the Company Secretary of what was then a large Milk products company, Woodruffs Dairies Pty. Ltd. of Port Melbourne. He and Don Dudgeon were good friends and Don enlisted Bob's help in organising the financial structure which enabled the Club to rebuild in partnership with the Melbourne City Council. Bob joined the club in January 1971 and remained an active member until he retired and moved out of Melbourne. He was made a Life Member in 1982. The Minute Books covering the early 1970's should reveal a more detailed account of Bob's involvement in helping the club survive such a catastrophic event. Thanks to Rod Hendley for providing this historical context for Bob.

Richmond ended a 72 year drought to win the Founders Cup at Henley this season.


TREASURER'S REPORT

The committee invested significant funds (\$78,300) this year to provide coaching for members. The 28% increase in membership revenues year on year is due to the growth (15%), membership mix, and fee increases (7-8%). Increases were due to rising costs, including a 12.5% increase in RV membership fees.

Hall hire revenues (up 43% to \$103,900) reflected increasing certainty in event planning (post COVID) and were just under 60% of pre-COVID levels. A hall hire marketing sub-committee has been formed to review and update our approach to increase this revenue stream. A refresh of the bathroom areas (\$300,000 commitment of which \$11,300 was spent in FY22-23), new function chairs and upgraded AV equipment (\$32,700) should also attract more corporate conference bookings.

Cash reserves continued to grow due to increasing revenues from memberships, hall hires and fundraising. From these reserves, a single scull and two cox boxes (\$7,300) were purchased during the year. The incoming FY23-24 committee will determine priorities for additional investment in fleet. Funds will need to be set aside for appliance replacement/major maintenance and boatshed storage renovations to support fleet growth. Larger value projects will require a multi-year savings program.

Funds received from hall hires and MLC's rental of part of a third bay support the club's investment in the development of its members' rowing skills and competitiveness. The high level of volunteered hours by committee members and others to manage these income streams and the club administration, maintenance, social and rowing programs means that labour costs are only incurred for coaches. These labour savings further underpin the club's investment which is shown below by category.

The 2022/2023 season was a successful one for Richmond Rowing Club, as we saw growth in both membership and participation in our mens and womens programs, headed by coaches Will Golding and Roy Zhang respectively and led by Head of Rowing Christine Sullivan.

The continued growth of the club has been driven by our ability to both attract and develop new members through strengthening relationships with TopRow, the revision of the structure and function of the development squad, and our the recruitment of experienced rowers who have observed both the presence and success of RRC crews.

This growth of the RRC competitive membership has both necessitated and facilitated a revised squad structure such that RRC can support long term athlete development by guiding athlete progression from the development squad, through to the intermediates and senior squads. This revised structure seeks to support both the ongoing development of club members and position RRC as the premiere development rowing club.

Progress towards this aim has been supported by the continued investment into coaching by the club and the appointment of Will Golding as Head Coach. The club has successfully retained a number of paid coaches namely, Lucca Meagher (Senior Coach, Development Squad), Meryll Evans (Stroke Coach, Development Squad), Joel Cain (Stroke Coach, Senior Women's Squad)

and Ainsley Raggatt (Stroke Coach, Senior Men's Squad) with the objective of increasing the professionalism of the rowing program being offered. The efforts of these coaches have been supported by a large cohort of volunteer coaches and coxes whose contributions have been critical to the ongoing success and development of the club.

The success of the 2022/2023 season, the revision of the squad structure and the recruitment of a coordinated and cohesive coaching team sees Richmond well positioned for success into the 2023/2024 season.

FACILITIES COORDINATOR REPORT

In 2022 coming off the back of snap COVID lockdowns there was still a general reluctance to forward book events and the club's hall hire revenue did suffer because of this. 2023 has seen a gradual increase in confidence that events will not be cancelled or sizes curtailed. However, our forward bookings into the coming peak Xmas period are slow in picking up but we are also seeing bookings into 2024 for weddings and special events

During this period, we took the opportunity to replace some of our function furniture and upgraded the club's chairs to a new design with trolleys to store, stack and move easier between events. However next on our list will be to replace some of the ageing tables and spruce up the outdoor furniture. Expect a working bee from the new facilities coordinator.

After much effort we secured a builder for our bathroom renovations which have hopefully been fully completed by the time of the AGM. A few defects and final fits and fixes were still being worked on at the time of drafting this report. A big thank you to Richie for all his work getting this project moving and to Nick Hart & the team from Total Facility Maintenance for the amazing work with a tight deadline. We hope all are impressed with the new look.

Hopefully the 2023-24 season will see the club's external hire events increase along with revenue that can again be put towards new equipment and facilities for the members. That said we cannot rely solely on the revenue from booking out the clubhouse. You as the members must make a concerted drive to raise funds through other means. Corporate Sponsorship, social events, raffles and quiz nights all contribute towards keeping the club's lights on and the fleet on the water.

Thank you to everyone that has assisted over the last year, however large or small your input has not gone unnoticed or unappreciated every little bit has helped this club to stay strong and survive.

Notes to the Financial Statements for the year ended 31 May 2023

Note 1: Statement of significant accounting policies

This note provides a list of all significant accounting policies adopted in the preparation of these financial statements. These policies have been consistently applied to all the years presented, unless stated.

(a) Basis of preparation

(i) Special purpose financial report

In the Committee's opinion, Richmond Rowing Club Inc is not a reporting entity because there are no users dependent on general purpose financial reports.

This special purpose financial report has been prepared for the sole purpose of complying with the Associations Incorporation Reform Act 2012 requirements to prepare and distribute a financial report to the members and must not be used for any other purpose.

The financial report has been prepared in accordance with the recognition and measurement principle of all applicable Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board which apply to not-for-profit entities. Richmond Rowing Club Inc is a not-for-profit entity for the purpose of preparing the financial statements.

(ii) Historical cost convention

The financial statements have been prepared on a historical cost basis.

(b) Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable. Amounts disclosed as revenue are net of returns, trade allowances, rebates and amounts collected on behalf of third parties.

The association recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the entity and specific criteria have been met for each of the association's activities as described below.

(i) Membership subscriptions

The membership year runs from 1 June to 31 May, consistent with the financial year. Subscriptions are invoiced at the commencement of the year or at the time of joining and revenue is recognised over the period of membership.

(ii) Lease of rowing shed and racking fee income

Income from lease of the rowing shed is recognised across the period of the lease as the obligation to provide the service is satisfied. Racking fees are invoiced annually. Amounts invoiced or paid in advance are deferred.

(iii) Race and Camp Fee income

Race fees and associated costs recharged to members related to competing at regattas or attending camps are recognised at completion of the regatta, and camp fees at the completion of the camp.

(iv) Fundraising/Social income

Fundraising/Social income is recognised at the time of the fundraising/social event.

(v) Hall Hire income

Revenue from the hire of the RRC hall is recognised when the hall hire occurs.

(vi) Donations and Grants

Where there are no ongoing performance obligations relating to the donation or grant, income is recognised when the association obtains control over the funds, which is generally at the time of receipt. Where the donation or grant is subject to substantive performance obligations the income is deferred and recognised as the performance obligations are met. Should donations or grants be in the form of assets, they are initially recognised at their fair value.

(vii) Coaching Levies

Coaching levies are recognised at the completion of the coaching period to which they relate.

(viii) Sponsorship revenue

Sponsorship revenue is recognised across the period of the sponsorship agreement as the obligation to carry the brand or provide the service is satisfied.

(ix) Fleet hire

Fleet hire fees are recognised at the completion of the hire period to which they relate.

(c) Property, plant and equipment

The Clubhouse was recognised at fair value at construction in 2014, less subsequent depreciation. All other property, plant and equipment is recognised at historical cost less depreciation.

Depreciation is calculated using the straight line method to allocate their cost net of their residual values, over their estimated useful lives or, in the case of the clubhouse and associated assets constructed on leased land, the shorter lease term as follows:

Clubhouse Leasehold Improvements 19.4 years (lease term)

Equipment, Bar Furniture and Fittings 3-10 years

Kitchen & Bar Re-fit 10 years

Boat Fleet, Oars, Trailer, Other

Equipment and Gym 10 years

All repairs and maintenance are charged to profit or loss during the reporting period in which they are incurred.

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in the Statement of Income and Expenditure.

(d) Trade debtors

Trade debtors are amounts due from customers for rental services provided or members related to the recovery of regatta fees. Trade debtors are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment.

(e) Trade creditors and other payables

These amounts represent liabilities for goods and services provided prior to the end of financial year which are unpaid. The amounts are unsecured and are usually paid within 30 days of recognition. Trade and other payables are presented as current liabilities unless payment is not due within 12 months after the reporting period. They are recognised initially at their fair value and subsequently measured at amortised cost using the effective interest method.

(f) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of associated GST, unless the GST incurred is not recoverable from the taxation authority. In this case it is recognised as part of the cost of acquisition of the asset or as part of the expense.

Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the taxation authority is included with other receivables or payables in the balance sheet.

(g) Income Tax

The association is a not for profit organisation and is exempt from income tax under section 50-45 of the Income Tax Assessment Act 1997.

(h) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, term deposits due within 12 months and bank deposits.

(i) Inventory

Inventory held for sale is measured at the lower of cost or net realisable value.

(j) Contributions of Assets

In accordance with AASB 1058, Income of Not-for Profit Entities Contributions, where an entity has an enforceable, sufficiently specific obligation to provide goods or services the transaction is accounted for under AASB 15, Revenue from Contracts with Customers. If a contract is in the scope of AASB 15, the total consideration received in the form of a contribution of assets is measured at fair value and must be allocated to the performance obligations in the contract. The consideration for each performance obligation is then recognised as income in the Statement of Income and Expenditure at the point of time, or over the period, the obligation is satisfied.

When the contribution of assets is a genuine donation without any enforceable, sufficiently specific obligation to provide goods or services the transaction is accounted for under AASB 1058 and recognised as income in the Statement of Income and Expenditure on receipt.

Contributed assets are recognised at the fair value of the assets received or receivable within the Statement of Financial Position.

In relation to the 2014 redevelopment of the Richmond Rowing Club, a tenant of the club contributed to the redevelopment in return for a sublease to access parts of the clubhouse over the period to 28 February 2034.

Accordingly the clubhouse was recognised at fair value of \$2,067,544 in 2014 with the associated Deferred Income of \$1,903,494, representing the fair value of the contribution by the tenant. Income (non-cash) associated with the sublease of the rowing shed related to the contribution is recognised over the sublease period of \$98,034 per annum. The clubhouse asset from the 2014 redevelopment recorded within the Statement of Financial Position is depreciated in line with Note 1 (c) amounting to \$106,483 per annum.

As at 31 May 2023 Income Received in Advance of \$1,045,696 is presented within the Statement of Financial Position (Current \$98,034; Non Current \$947,662) related to this sublease, to be recognised as Income (non-cash) over the period to 28 February 2034 when the sub lease expires.

(k) Right-of-Use Assets of Not-for-Profit Entities

The AASB (2018-8) made amendments to AASB 16 Leases, AASB 1049 Whole of Government and General Government Sector Financial Reporting and AASB 1058 Income of Not-for-Profit Entities which provide a temporary option for not-for-profit lessees to measure right-of-use assets relating to concessionary leases at cost rather than at fair value. Concessionary leases in this context are leases that have at inception significantly below-market terms and conditions, principally to enable the entity to further its objectives.

The association has elected to measure, at initial recognition, its concessionary lease of land from Melbourne City Council at cost such that the associated right-of-use asset and lease liability is immaterial for presentation within the financial statements.

(I) Commitments

The club embarked on a bathroom renovation in June 2023 and has committed to expenditure of \$301,246 (excluding GST). A deposit of \$11,255 (2022 \$-) in relation to the works was made in May 2023. These leasehold improvements are expected to be completed in July 2023.

(m) Standards and Amendments adopted during the year

There were no material impacts from new accounting standards adopted during the year.

5. Related parties

During the year the association engaged Leemark Fire Protection Pty Ltd (Leemark) to complete inspections and repairs on fire equipment and exit and emergency lighting. Ironbolt is solely owned, and SecureChoice Techologies Pty Ltd is partly controlled, by a member of the Richmond Rowing Club Inc. who was also a committee member until November 2021. The value of services provided during the period the member was a committee member totaled \$ 0 (2022 \$1,000). The transactions occurred at terms equivalent or lower than those that prevail in arm's length transactions.
